



## Donation/Sponsorship Request

### Eligibility Requirements

- Donation/Sponsor request to benefit an individual's cause or a single family's cause are not eligible.
- Donations must go to benefit nonprofit organization with tax exemption status under Internal Revenue Service code **501(c)(3)**. However, requests from schools (private or public) or school-affiliated organizations like FFA chapters *will be considered*.

### Donation Guidelines

- If request is granted, monetary donations in the form of a check will be made payable to organization, **NOT AN INDIVIDUAL**.
- Ag-Power, Inc. requires a minimum 30-day notice for donation requests.
- Donation requests must be submitted in writing, using the Ag-Power Donation Request Form (available online at [www.ag-power.com](http://www.ag-power.com)) and submitted by email or mail to Ag-Power at:
